If you wish to be eligible for a Trade / Vender Space, your application must be postmarked by January 1, 2017. All spaces after January 1, 2017 will be filled on a first come first serve basis. Members will be given first priority. Applications for 2017 rendezvous will be accepted Monday, September 5, 2016 in Registration. Confirmations will be mailed out no later than April 1, 2017 for applications submitted by January 1, 2017.
